2 Basic Technical Parameters

2.1 Video Share & Image Share

2.1.1 Introduction

This section sets out specific Interworking Service terms relating to the exchange of Video and Image Share Interworking Service traffic between the Parties, whereby the Parties agree to convey and terminate the Video and Image Share traffic sent from the Originating Party to the Receiving Party.

2.1.2 Video and Image Share Interworking Services

In order to allow Subscribers from one Party to share videos and images with a Subscriber from the other Party, the Parties agree to establish, operate and provide Video and Image Share Interworking between each other's Network for the duration of this Agreement.

2.1.3 Commercial requirements

The Parties shall be entitled to apply a charge for the Video and Image Share Interworking Service.

Parties agree that any associated communication services such as Voice or Instant Messaging (IM) from which Video and Image Share Interworking Service(s) may be invoked will be charged separately from the Video and Image Share Interworking Service and that charging for any such underlying communication services is not in the scope of this Agreement.

2.1.4 Charging Principles for Video Share Interworking Service

The Receiving Party is entitled to charge the Originating Party a Charge for Video Share traffic sent from the Originating Party's Network.

The Video Share Interworking Service shall be charged in accordance with GSMA PRD IN.27.

Parties shall charge only for the successful invocations of Video Share.

In case of point-to-multipoint invocation of Video Share, a separate charge applies per recipient.

2.1.5 Charging Principles for Image Share Interworking Service

The Receiving Party is entitled to charge the Originating Party for Image Share traffic sent from the Originating Party's Network.

The Image Share Interworking Service shall be charged according GSMA PRD IN.27.

In case of point-to-multipoint invocation of Image Share, a separate Charge applies per Subscriber in the Receiving Network.

2.2 One-to-One Chat and Group Chat

2.2.1 Introduction

This section sets out specific Interworking Service terms relating to the exchange of Instant Messaging Interworking Service traffic between the Parties, whereby the Parties agree to convey and terminate the Instant Messaging traffic received from the Originating Party to the Recipient Party.

2.2.2 Instant Messaging Interworking Service

In order to allow Subscribers from one Party to send Instant Messages to a Subscriber from the other Party, the Parties agree to establish, operate and provide Instant Messaging Interworking between each other for the duration of this Agreement.

2.2.3 Charging Principles for Instant Messaging Interworking Service

The charging model for each Instant Messaging is based on GSMA PRD IN.27.

2.3 File Transfer

2.3.1 Introduction

This section sets out specific Interworking Service specific terms relating to the exchange of File Transfer Interworking Service traffic between the Parties, whereby the Parties agree to convey and terminate the File Transfer traffic received from the Originating Party to the Recipient Party.

2.3.2 File Transfer Interworking Services

In order to allow Subscribers from one Party to send File Transfer to a Subscriber from the other Party, the Parties agree to establish, operate and provide File Transfer Interworking between each other's Networks for the duration of this Agreement.

2.3.3 Charging Principles for File Transfer Interworking Service

The Receiving Party is entitled to charge the Originating Party for File Transfer traffic sent from the Originating Party's Network

The File Transfer Interworking Service shall be charged based on GSMA PRD IN.27.

In case of point-to-multipoint invocation of File Transfer, a separate charge applies per Subscriber in the Receiving Network.
